LEGAL BASIS FOR MANAGING YOUR PERSONAL INFORMATION

: the legal basis for gathering and using personal information is provided by EU legislation, and depends on the personal information gathered and the specific manner in which it is gathered.

- In order to fulfil a contract you have signed with us
- because you have given us your consent to do so
- where using such data falls within our legitimate interests and objectives, and does not therefore impinge on your rights in this area.
- in order to carry out or receive payments
- in order to comply with legal requirements.

WHO DO WE COMMUNICATE YOUR DATA TO? Your personal data will be supplied to other organisations, who will in turn be responsible for how it is handled (as per Article 28 of EU Regulation 679 of 2016) or who in turn act on under the authority of the Data Handling Manager (Article 29 of EU Regulation 679 of 2016), for the reasons or motives listed above. To be precise, your data will be supplied to: our sales and distribution force; companies who manage our ICT and communication systems (including email); companies we hire as consultants; public juridical and investigative bodies in order to meet our legal obligations (as requested),for accountancy purposes, your data can be sent to our accountants or other commercial information companies where needed to evaluate solvency and payment history and/or as needed in order to recover debts incurred. As mentioned above, each of these organisations is in turn responsible for how your data is handled and are to be considered autonomous Data Handlers in that sense. TRANSFER OF YOUR DATA TO A THIRD-COUNTRY OR AN INTERNATIONAL ORGANISATION, AND YOUR RIGHTS

Personal data supplied to us can be transferred to countries within and outside the European Union for the reasons and motives listed above. They can also be transferred:

- to third-party countries or international organisations that have supplied adequate guarantees in this field and which offer defendable legal rights and recourse (as per Article 46 of EU regulation 679 of 2016), with the contractual and other clauses of paragraph 3 of Article 46.
- to third-party countries or international organisations on the basis of legal requirements for companies that form part of the same commercial organisation (Article 47 of EU regulation 679 of 2016).
- to third-party countries or international organisations on the basis of specific dispensations (Article 49 of EU regulation 679 of 2016).

HOW LONG WILL WE STORE YOUR DATE, AND HOW IS THAT PERIOD CALCULATED?

We store your personal data only for the time strictly necessary for the motives or reasons listed above. All data is stored in compliance with the legal obligations imposed on us (such as laws that require us not to destroy data), to help resolve any legal disputes, to carry out the agreements we enter into and to allow us to carry out our Policies in this area. We also store data for internal review purposes. Generally, this latter category of information is stored for a shorter time, except where they are necessary in order to strengthen our security systems, improve the functionality of our services, or where we are required by law to preserve them for a longer period of time.

HOW TO EXERCISE YOUR RIGHTS

You can exercise the rights listed in EU regulation 679 of 2016 in this area by contacting the Data controller, via an email to info@cartenplast.it or via the company postal address listed above.

You can ask at any time to access your data (Article 15), that your data be rectified (Article 16) or deleted (Article 17), that data handling be limited (Article 18) or to oppose their handling (on the basis of legitimate interest, as per Article 21).

Revoking your consent: data handling is not legally based on consent but on legitimate interests. Whenever it is based on consent, you can revoke that consent at any time within impacting on the legitimacy of the data handling conducted previous to the revocation. To register your opposition to data handling or to exercise any of your other rights, please write to info@cartenplast.it. You can of course always take your case to a competent legal authority.

Communicating personal data is not obligatory. You can choose whether or not to supply personal data in the dedicated areas of our Website. However, failure to give such consent can render it impossible for the data controller to offer the full range of services. There is no automated decision-making process in these cases.
